CAG'S NOTE

Strengthening financial management and establishing transparency and parliamentary accountability in the public sector have become the major issues of the Office of the Comptroller and Auditor General of Bangladesh. The Office of the Comptroller and Auditor General (OCAG) of Bangladesh is committed to operating as a critical link in the accountability framework involving the public sector, legislative and the people at large.

In the age of rapidly changing technologies, auditing and accounting professionals face many challenges which they should ward off with professional knowledge and due diligence. Using technology some public services can be decentralized to deliver the service at the hands of service recipients. Audit related information can be made available and accessible through application of new information and communication based technologies.

Revolutionary technologies and technological ideas like Artificial Intelligence (AI), Machine Learning (ML), Big Data, Blockchain will play a greater role in the field of auditing and accounting in near future. Both public sector auditors and accountants need to be adapted with these concepts and technologies. We need a knowledge-based efficient human resource not only in the field of science and technology, but also in the discipline of Law, Economics, Finance, and Accounting.

During "July-December 2019", the OCAG submitted its candidature for the "External Auditor" for UNIDO for the period from July 2020 to June 2022 which signifies the professional strength of the Supreme Audit Institutions (SAI) of Bangladesh.

On 18 November 2019, the existing organogram of the Audit and Accounts Department has been upgraded. As a result, more than 710 new posts (both permanent and temporary) have been created and 7 new Audit Directorates have been formed. It is expected that with the upgraded organogram, there will be a scope of recruitment of more equipped manpower which will gear up and enhance the quality of audit activities.

SAI Bangladesh organized SAI PMF Review Workshop in Dhaka

Office of the Comptroller and Auditor General of Bangladesh (SAI Bangladesh) organized an international workshop in Dhaka named SAI Performance Measurement Framework (PMF) Review Workshop from 13 to 17 October 2019 with collaboration with ASOSAI (Asian Organization of Supreme Audit Institutions) and IDI (INTOSAI Development Initiative). 37 participants from 14 SAIs (Mongolia, Maldives, Myanmar, Bhutan, Philippines, Thailand, Malaysia, Indonesia, Pakistan, Nepal, Laos, UAE, Norway and Bangladesh) joined the workshop. Mr. Tanveer Akhter Hossain Khan, Mst. Mahabuba Begum, Toufique Shafigul Islam, Nasimul Islam participated the workshop from SAI Bangladesh. This workshop is the part of IDI-ASOSAI joint initiative called the Strategy, Performance Measurement and Reporting (SPMR) program. The 5 day long workshop was conducted by the resource persons of IDI and ASOSAI. Deputy CAG (A&R) Mr. Mahabubul Haque inaugurated the workshop along with Deputy CAG (Procedure) Mr. Shariful Islam. OCAG organized half day program to visit national parliament house for the participants and guests of the workshop.

Besides OCAG arranged a cultural program and dinner in honor of the guests. Controller General of Accounts (CGA) Mr. Zahurul Islam and all the senior officers of OCAG were present in the program.

SAI Bangladesh participated in UNIDO External Auditor Election Campaign 2019

In 2019, the OCAG of Bangladesh participated in the event of the election of the External Auditor to the United Nations Industrial Development Organization (UNIDO) along with its counterparts from Russia, Philippines, Indonesia, Bhutan. In this connection, the OCAG organized a formal dinner on 1st October, 2019 in Hotel Intercontinental for His/Her Excellency Ambassadors and High Commissioners from the UNIDO member countries having embassies in Dhaka, Bangladesh to introduce the candidature of Bangladesh for the External Auditor position of UNIDO. In addition, the Comptroller and Auditor General (CAG) of Bangladesh visited the Headquarter of UNIDO in Vienna, Austria on October 5, 2019 and met with the chairs from different groups of the United Nations (UN) Headquarter where he introduced the candidacy of Bangladesh for UNIDO External Auditor election.

Subsequently, the delegates from SAI Bangladesh met with the chairs from different groups of UN Headquarter in New York. The campaign for the election of the External Auditor to the UNIDO was a remarkable experience for the OCAG of Bangladesh.

South Asia Accountability and Transparency Roundtable held in Dhaka

World Bank in collaboration with the Government of Bangladesh organized the South Asia Financial Accountability and Transparency Roundtable in Dhaka on November 17, 2019. The prime objective of the roundtable was to explore whether formal and informal financial accountability institutions can mutually benefit through making their own chain of accountability stronger together with generating ideas for a

structured framework to promote financial accountability and transparency in the government. It brought together the key stakeholders in accountability institutions including the Speaker of the Parliament, Chairpersons of Public Accounts Committee (PAC) and Public Estimates Committee (PEC), Comptroller and Auditor General, Ministry of Finance, Anti-Corruption Commission, Key Government Officials, Expert from SAI-India, Civil Society Organizations, Media, and Development Partners.

The CAG of Bangladesh raised following issues in this workshop:

- SAI needs to be a model organization for all other public offices. However, it will not be possible if all the processes and all the players within the accountability framework do not function properly. Not only the Auditor General, the role of Public Accounts Committee of the Parliament is also very crucial in promoting accountability in government spending.
- When does the audit report become a public document? - This issue still remains debatable. As per the constitution, it cannot be treated as a public document until it is submitted to the parliament. It takes at least 2 years to complete the full cycle of an audit report. The time lag hinders the accountability processes. It makes the process of accountability less effective since 'justice delayed' is 'justice denied'.
- To improve the effectiveness of the accountability framework, collaboration among the accountability organizations is necessary. As the audit report is finalized after a significantly long period of occurrence of irregularities, it would be beneficial if the initial findings of the audit could be shared with other accountability agencies like Anti-Corruption Commission (ACC) and media for taking actions at their end.

Organogram of the Audit and Accounts Department has been restructured

A major organizational restructuring has been taken place in the history of Audit and Accounts Department in November 2019. A

total of 103 posts have been upgraded, 710 posts have been created and 7 new Audit Directorates have been established through this restructuring. The post of Deputy CAG (Senior) has been upgraded to grade-1; the posts of Deputy CAG (A&R), SFC (Army) and Additional CGA (Admin) have been upgraded to grade-2; 11 posts namely 8 DCAs and 3 CA&FOs (LGED, Education, and Agriculture) have been upgraded to grade-4; and 32 CA&FO posts and 56 DA&FO posts have been upgraded to grade-5 and grade-6 respectively. The summary of newly created cadre posts are: grade-3 (6 posts of Directorate Generals of Audit), grade-5 (7 posts), grade-6 (62 posts), grade-9 (110 posts). Besides, 525 noncadre posts of different grades have been created. With the establishment of seven new audit directorates, the number of total Audit Directorates has now become 17. Overall, the cadre strength of BCS: Audit and Accounts has taken the following shape:

DG FIMA Dr. Shyamal Kanti Chowdhury said that as the training wing of the office of the CAG of Bangladesh, FIMA is assisting to materialize Vision 2041 by offering various training programs to the officials and employees of Audit and Accounts department as well as officials and employees of different ministries, departments and institutions of Bangladesh government. At present, FIMA has one six-storied academic building, two dormitories (one three-storied for the officers and the other is four-storied for the employees) and one three-storied staff quarter in its two acres of land. FIMA requires more infrastructure as the operation has broadened much compared to its initiation in 2005.

Dr. Shyamal Kanti Chowdhury emphasized on the need for a conference centre, a dormitory and a training centre of international standards, another six-storied academic building, one four-storied officers' dormitory, one cafeteria and utility building, playground, gymnasium and sports centre in FIMA. Request was made to Finance Secretary for land acquisition for FIMA to meet future demands and transform FIMA into a training academy of international standard. Moreover, DG FIMA made a proposal to establish an Audit Foundation as a wing of FIMA in the form of not-for-profit organization. He also added that the foundation will help to receive assistance from development partners to organize effective training and researches.

An induction course was organized for the freshly appointed auditors of Controller General Defense Finance (CGDF) office in FIMA on 26 December 2019. Mr. Md. Zahurul Islam Takes over Charge as New CGA



Mr. Md. Zahurul Islam has been appointed as the Controller General of Accounts (CGA) on October 13, 2019. Prior to this appointment, he was serving as Additional

Director General (Finance), Bangladesh Railway.

Born on January 29, 1962 in Pabna, Mr. Islam joined the Bangladesh Civil Service: Audit and Accounts in 1988 (1985 batch). He did his B. Com (Hons.) and M. Com in Accounting from the University of Dhaka. He obtained his second masters degree in Accounting and Finance from the University of Birmingham,

UK and MBA in Finance and Accounting from the University of Honolulu, USA.

In addition to having an illustrious career embellished with vast working experience in Audit and Accounts Department, Mr. Md. Zahurul Islam served as Chief Accounts and Finance Officers (CAFO) of Internal Resource Division of the Ministry of Finance; CAFO of the Ministry of Agriculture and Ministry of Environment, Forest and Climate Change; Director of Civil Audit Directorate, and Defense Audit Directorate: Finance Controller of Bangladesh Army (Pay-2), Bangladesh Ordnance Factory, and Bangladesh Army (Log Area); Senior Finance Controller of Bangladesh Air Force, Bangladesh Navy, and Defense Purchase, Additional Financial Advisor and Chief Accounts Officer (West); Financial Advisor and Chief Accounts Officer (Project) of Bangladesh Railways; and Director General of Commercial Audit Directorate. He was the Project Director of SPEMP-B: Strengthening the Office of the Comptroller and Auditor General Project. Mr. Islam further augmented his professional portfolio by working as consultants in the ADB-financed 'Urban Primary Health Care Project' and IDAfinanced 'National Agriculture Technology Project'. Over the course of his career, he also gained the invaluable experience of working as a member of a Joint Audit Team comprised of auditors from SAI Bangladesh and SAI Pakistan that audited the accounts of SAARC Secretariat, SAARC-Japan special fund and SAARC regional offices located in Nepal, India, Pakistan and Bangladesh.

Adding an international dimension to his decorated national career, Mr. Islam visited USA, UK, Australia, Malaysia, Singapore, India, Pakistan, Thailand, Myanmar, Kuwait, Saudi Arabia, the United Arab Emirates, Qatar, Italy and South Africa for government auditing purposes. Moreover, he attended many professional training courses and seminars abroad on Public Financial Management. A few highlights are like audit of public works and projects in India, implementation of IPSAS in ADB headquarter

Recent Initiatives on Accounting Activities

DEVELOPMENT OF iBAS++

- Prepared a brief report on "Functional requirements on iBAS++: Accounting Module" by Core Group for iBAS++.
- Designed control measures for Personal Ledger (P/L) accounts for autonomous bodies' fund release.

ONLINE PAY BILL SUBMISSION FOR STAFF BY CAFO/CAG, PSC, EC

- Online bill submission of gazetted officers is active in all pay-points.
- Coverage for implementation of DDO Module has been widened. 24,444 nongazetted employees are included in DDO module for online bill submission in iBAS++.

EFT SERVICE AT DISTRICT AND UPAZILLA LEVEL

- All of the 541 pay-points (50 CAFOs, 8 DCAs, 56 DAOs and 427 UAOs) have been brought under EFT coverage.
- All Chief Accounts and Finance Offices collected D-half of pensioners from bank. 116,615 pensioners have been brought under EFT coverage (Last 6 months). Total 2,04,080 pensioners are under EFT coverage.

Activities of Different Audit Directorates

1. Foreign Aided Projects Audit Directorate (FAPAD)

The Foreign Aided Projects Audit Directorate (FAPAD) is one of the dedicated audit directorates among the 17 different audit directorates under OCAG of Bangladesh. This specialized arm of OCAG is entrusted to auditing the activities of all development and technical assistance projects and programs in the public sector funded by foreign assistance.

FAPAD is continuing its activities to implement the mission and vision of the OCAG. The audit activities of 397 projects in the financial year 2018-2019 are under its jurisdiction. Of these, data collection of 170 projects in the first phase up to 31 December 2020 (audit year 2019-2020) has been completed by 38 audit teams. In the first phase, 136 audit inspection reports have been sent to the concerned institutions.

Entry Meeting

FAPAD organized an entry meeting with IDA funded projects for FY 2018-2019 on 24 July 2019 at the conference room of FAPAD with representatives from each executing agency.

Another entry meeting was held on 31 July 2019 at LGED Conference Room (level-12) RDEC Bhaban, Agargaon, Dhaka. The meeting was held among the FAPAD, ADB high officials and Project Directors

(PDs) of the 72 projects. The main agenda of the meeting were Financial Reporting and Auditing, Requirement, Reconciliation, Statement between APFS and LFIS etc. of ADB funded projects.

Exit Meeting

FAPAD organized an exit meeting with IDA and ADB funded projects for FY 2018-2019 on 30 and 31 December 2019. PDs along with one representative attended from each executive agency. Officials from concerned projects explained their views and comments regarding audit observations in presence of the Director General of FAPAD.

To date, only these 4 field offices in Bangladesh outside Dhaka receiving staff payment through EFT. Now, all the employees of this directorate are receiving their salary through EFT.
