1. FOREWORD: IN RETROSPECT



Establishing transparency and parliamentary accountability of the Responsible Party within the public sector is one of the major tasks of the Office of the Comptroller and Auditor General (OCAG) of Bangladesh. As a state auditor, OCAG should play its due role not only within the Budgetary Central Government, but also within Extra Budgetary Entities and Local Government. In the age of rapidly changing technologies, auditing and accounting professionals face many challenges which they should ward off with professional knowledge and due diligence. Using technology some public services can be decentralised to deliver the service at the hands of service recipients. For example, Electronic Fund Transfer (EFT) can play a great role in easing the public service through

reaching out to pensioners. This year, EFT activity has been geared up through the Chief Accounts and Finance Office (CAFO), Pension and Fund Management to mitigate the sufferings of the pensioners. Moreover, a security assessment activity of the iBAS++ system by PricewaterhouseCoopers (PwC) is also going on which will help in fortifying iBAS++ security. Audit Department will play its due role with the vision "Centralised accounts keeping with decentralised service delivery reducing cost of audit activities."

Initiatives have been taken to update the ongoing digital audit management system named Audit Management and Monitoring System (AMMS). For this, OCAG has taken steps for restructuring, renovating and upgrading the Data Centre. Nowadays software like IDEA, ACL, and Microsoft Excel, etc. are being used in the field of audit data analysis to increase audit quality and save time. Analytical skills and knowledge on Public Financial Management (PFM) activity will be of significant value. Audit people should adopt the skills of quick learning by using modern technologies to cope up with the ever-increasing challenges of PFM activities. Restructuring of Audit and Accounts Department has certainly strengthened the working capability of the Audit Directorates. To capitalise the restructuring facility, OCAG has also taken initiatives in terms of professional development of its human resources by providing participating opportunity and funding for professional courses like CIPFA, CISA, CIA, etc. If the Audit Directorates can play their due role both as primary auditor and sub-auditor, the impact of it on the government and the society will be huge.

Revolutionary technologies and technological ideas like Artificial Intelligence (AI), Machine Learning (ML), Big Data, Blockchain will play a greater role in the field of audit and accounting in near future. Both public sector auditors and accountants need to adapt with these concepts and technologies. We need a knowledge-based efficient human resource not only in the field of science and technology, but also in the discipline of Law, Economics, Finance, and Accounting. OCAG is one of the major stakeholders of Public Financial Management (PFM) which encompasses budget formulation, budget execution, accounting, and reporting. In this regard, OCAG is committed to discharging its responsibility to strengthen the knowledge base of its officials regarding the concepts, features and legal framework of PFM. OCAG has taken some initiatives like PFM lectures series and sharing of PFM related documents, etc. as part of delivering this responsibility. The OCAG has taken these steps with a view to building a robust, comprehensive, and homogeneous knowledge base of its officials. Quality audit is one of the benchmarks in ensuring parliamentary accountability and it is expected that OCAG will be an impact maker in rendering quality public service through quality audit.

2. INTRODUCING SUPREME AUDIT INSTITUTION OF BANGLADESH

a. About Us



The Office of the Comptroller and Auditor General (OCAG), the Supreme Audit Institution (SAI) of responsible for Bangladesh is auditing government receipts and public spending to ascertain whether expenditures have yielded value for money in government offices, public bodies and statutory organisations. Appointed by the President of the Republic, the Comptroller and Auditor General (CAG) heads the Supreme Audit Institution. Constitutional mandate of Comptrollership provides the CAG with the authority to decide the manner and the form in which the government accounts are maintained and disclosed.

The Constitution of the People's Republic of Bangladesh provides the CAG with absolute operational independence. CAG is not subject to the influence or control of any other authority in determining the nature, scope and extent of audit and has unrestricted access to all documents required for carrying out audit.

Directors General, the heads of the Audit Directorates are responsible for conducting audit on behalf of the CAG in their respective jurisdictions. Alongside the traditional approach to carry out financial, compliance or regularity audits, the OCAG is now conducting performance audit to determine economy, efficiency and effectiveness in the management of public resources.

In recent years, there has been increased use of IT in the government offices, as a result, the scope for the IT audit has also increased manifold. To keep pace with the vision of the present government's 'Digital Bangladesh', OCAG Bangladesh has given emphasis on digitalisation of audit activities and increased IT auditing.

b. Constitutional Mandate

Constitution of the People's Republic of Bangladesh Part-VIII THE COMPTROLLER AND AUDITOR-GENERAL

- **127.** (1) There shall be a Comptroller and Auditor-General of Bangladesh (hereinafter referred to as the Auditor General) who shall be appointed by the President.
- Establishment of office of Auditor General
- (2) Subject to the provisions of this Constitution and of any law made by Parliament, the conditions of service of the Auditor General shall be such as the President may, by order, determine.
- Functions of Auditor
- **128.** (1) The public accounts of the Republic and of all courts of law and all authorities and officers of the Government shall be audited and reported on by the Auditor General and for that purpose he or any person authorised by him in that behalf shall have access to all records, books, vouchers, documents, cash, stamps, securities, stores or other government property in the possession of any person in the service of the Republic.
- (2) Without prejudice to the provisions of clause (1), if it is prescribed by law in the case of anybody corporate directly established by law, the accounts of that body corporate shall be audited and reported on by such person as may be so prescribed.
- (3) Parliament may by law require the Auditor General to exercise such functions, in addition to those specified in clause (1), as such law may prescribe, and until provision is made by law under this clause the President may, by order, make such provision.
- (4) The Auditor General, in the exercise of these functions under clause (1), shall not be subject to the direction or control of any other person or authority.
- **129.** (1) The Auditor General shall, subject to the provisions of this article, hold office for five years from the date on which he entered upon his office, or until he attains the age of sixty-five years, whichever is earlier.


Term of office of Auditor General

- (2) The Auditor General shall not be removed from his office except in like manner and on the like grounds as a Judge of the Supreme Court.
- (3) The Auditor General may resign his office by writing under his hand addressed to the President.
- (4) On ceasing to hold office the Auditor General shall not be eligible for further office in the service of the Republic.
- **130.** At any time when the office of Auditor General is vacant, or the President is satisfied that the Auditor General is unable to perform his functions on account of absence, illness or any other cause, the President may appoint a person to act as Auditor General and to perform the functions of that office until an appointment is made under article 127 or, as the case may be until the Auditor General resumes the functions of his office.
- Acting Auditor General
- **131.** The public accounts of the Republic shall be kept in such form and in such manner as the Auditor General may, with the approval of the President, prescribe.
- Form and manner of keeping public accounts
- **132**. The reports of the Auditor General relating to the Reports of public accounts of the Republic shall be submitted to the President, who shall cause them to be laid before Parliament.

Reports of Auditor General to be laid before Parliament



Pre-Auditing Responsibilities


Pre-auditing responsibilities are undertaken by the OCAG on the backdrop of prevalent control weaknesses and inadequate internal audit functions within the public sector organisations. The offices of the Controller General of Accounts (CGA), Controller General Defence Finance (CGDF) and Additional Director General (Finance), Bangladesh Railway assist the CAG in pre-audit of all expenditures incurred by the government. These offices are also assigned with the responsibilities of compiling the Finance Accounts and Appropriation Accounts of the government. The allocations of functions to these offices are mentioned below:



e. Human Resources





The Supreme Audit Institution requires special competence from its workforce to conduct its varied auditing tasks. The OCAG considers the skills and expertise of its staff as the most important aspect to perform its duties effectively. The OCAG employees possesses a wide range of educational background and professional credentials which are particularly useful in carrying out the audit engagements, especially in performance audit, environmental audit, and the emerging audit issues.

The OCAG has taken initiatives to increase its expertise in public financial management including accounting and auditing qualifications. Officers belonging to Bangladesh Civil Service (BCS) are recruited by Bangladesh Public Service Commission. The other category of staff are recruited directly by the OCAG who are promoted to the higher ranks after qualifying departmental examination known as the Sub-ordinate Accounts Service (SAS) exam.

In order to build a strong competence based human capital, the OCAG encourages professionalism by providing platforms for acquiring qualifications and certifications like ACCA (Association of Chartered Certified Accountants), CIPFA (Chartered Institute of Public Finance and Accountancy), CISA (Certified Information Systems Auditor), CIA (Certified Internal Auditor), and CFE (Certified Fraud Examiner) by its officials. Moreover, OCAG provided scholarships for some of these courses in the past.

Approximately, nine thousand officers and staff are currently working in the OCAG of which sixteen percent are women. The bar graph here indicates the gender ratio at officer level (grade: 1 to 9) and staff level (grade: 10 to 20). At present, there are approximately fifteen and sixteen percent women at officer and staff level respectively.



In the year 2019, OCAG covered audits of various sectors of the government. Special emphasis was given to cover more risky sectors including health, power, banking, public works, education, communication etc. In preparing these reports, attention was given to audit quality to ensure transparency and accountability of the government earnings and expenditure. It is expected that, maximum utilisation of government funds and reduced wastage of public resources would be ensured in the sectors audited. A list of audit reports with title is given below:

e. Finance Accounts and Appropriation Accounts

Government Accounts

The Comptroller and Auditor General of Bangladesh certifies the annual `Finance Accounts' and `Appropriation Accounts' for submission to the Honorable president as per section 4 of the Comptroller and Auditor General (Additional Functions) Act, 1974. Finance Accounts show the annual receipts and disbursements for the purpose of the government, distinguished under the respective heads thereof, and particulars of its balances and outstanding liabilities containing such other information as to its financial position. While, a comparative statement showing detailed head-wise final budget allocation and actual expenditure of different Ministries/Divisions and their subordinate offices with explanation of variances (if any) are included in the Appropriation Accounts.

All financial transactions of the Government of Bangladesh as per constitution are reflected in the Consolidated Fund and the Public Account of the Republic. As per Article 84 of the constitution of the people's republic of Bangladesh, the definitions of Consolidated Fund and Public Account are as follows:

Consolidated Fund: All revenues received by the government, all loans raised by the government, and all moneys received by it in repayment of any loan, shall form part of one fund to be known as the Consolidated Fund.

Public Account: All other public moneys received by or on behalf of the government shall be credited to the Public Account of the Republic.

The custody of public moneys, their payment into and the withdrawal from the Consolidated Fund, or, as the case may be, the Public Account of the Republic, and matters concerned with or ancillary to the matters aforesaid, are regulated by act of parliament.

Government accounts are kept on `cash basis'. The Controller General of Accounts (CGA) is responsible for maintaining the accounts of government's cash balance in the central bank.

Mandated by the Article 76 (1) (a) of the Constitution and Rule 233 of the Rules of Procedure of the Parliament, the Public Accounts Committee (PAC) examines the reports.

The PAC selects important observations of the audit reports with the help of OCAG for detailed examination and holds hearings to the Principal Accounting Officers i.e., the Secretaries of different Ministries/Divisions. It makes recommendations and submits reports to the Parliament. The OCAG provides necessary support to the PAC in its effective functioning. During the full committee meeting, the CAG remains present as 'amicus curie' along with the related officers of the respective Audit Directorates. The officers of the OCAG attached to the Parliament assist the committee in preparation of reports of the PAC. Concerned officers of the OCAG remain present in the meetings of the Public Undertakings Committee (PUC) and Committee on Estimates (EC) when they are requested to.

a. Public Accounts Committee (PAC) Meetings

The OCAG submitted 1,114 audit reports to the Parliament since the independence of Bangladesh. Among those, 987 audit reports were discussed up to the 20th meeting of PAC of 11th Parliament. The number of undiscussed reports is 102. 34 new audit and accounts reports are submitted to Honorable President which will be submitted to PAC very soon.

The Public Accounts Committee (PAC) of the 11th Parliament has undertaken an unprecedented step in resolving the existing undiscussed reports. Because of the proactive approach by the PAC and OCAG, a large number of audit observations included in reports have been discussed during 2019.

The 11th Parliament was constituted on February 2019. Since then, a total number of 20 meetings were held in the 11th Parliament to date. The PAC examined 85 audit observations of 10 undiscussed audit reports during this period.

b. PAC Report of 11th Parliament Tabled

The Public Accounts Committee (PAC) of 11th parliament examined 103 audit observation of 10 audit reports in 14 sitting; Among these 103 audit observations, 29 audit observations were fully settled, 22 audit observations were partially settled, 15 audit observations are still pending to be settled upon recovery from the concerned responsible party and for rest of the 37 audit observations, various instructions were given by PAC to concerned audit directorates including further evaluation of audit evidence. All these observations involve an amount of Tk. 1,202.92 crore, out of which Tk. 134.64 crore was recovered and adjusted through audit recommendations.



The Comptroller and Auditor General of Bangladesh raised following issues in the workshop:

 SAI needs to be a model organization for all other public offices. However, it will not be possible if all the processes and all the players within the accountability framework do not function properly. Not only the Auditor General, the role of Public Accounts Committee of the Parliament is also very crucial in promoting accountability in government spending.

- When does the audit report become a public document? This issue still remains debatable. As per the constitution, it cannot be treated as a public document until it is submitted to the parliament. It takes at least 2 years to complete the full cycle of an audit report. The time lag hinders the accountability processes. It makes the process of accountability less effective since 'justice delayed' is 'justice denied'.
- To improve the effectiveness of the accountability framework, collaboration among the accountability organizations is necessary. As the audit report is finalized after a significantly long period of occurrence of irregularities, it would be beneficial if the initial findings of the audit could be shared with other accountability agencies like Anti-Corruption Commission (ACC) and media for taking actions at their end.

Organogram of the Audit and Accounts Department has been restructured

A major organisational restructuring has been taken place in the history of Audit and Accounts Department in November 2019. A total of 103 posts have been upgraded, 710 posts have been created and 7 new Audit Directorates have been established through this restructuring. The post of Deputy CAG (Senior) has been upgraded to grade-1; the posts of Deputy CAG (A&R), SFC (Army) and Additional CGA (Admin) have been upgraded to grade-2; 11 posts namely 8 DCAs and 3 CA&FOs (LGED, Education, and Agriculture) have been upgraded to grade-4; and 32 CA&FO posts and 56 DA&FO posts have been upgraded to grade-5 and grade-6 respectively. The summary of newly created cadre posts are: grade-3 (6 posts of Directorate Generals of Audit), grade-5 (7 posts), grade-6 (62 posts), grade-9 (110 posts). Besides, 525 noncadre posts of different grades have also been created. With the establishment of seven new audit directorates, the number of total Audit Directorates has now become 17. Overall, the cadre strength of BCS: Audit and Accounts has taken the following shape:
