CAG'S NOTE

The Supreme Audit Institution (SAI), a public oversight body, has the mandate to review the government's revenue collection, expenditure and to issue its own statement on the execution of the budget and the strength of the Public Financial Management (PFM) systems. As PFM underlies all government's activities encompassing budget cycle, budget formulation, budget execution, accounting and reporting, Office of the Comptroller and Auditor General (OCAG) is one of the major stakeholders of Public Financial Management (PFM) as well as its reform process. For this reason, OCAG has the responsibility to strengthen the knowledge base of its officials regarding the concepts, features and legal framework of PFM. As part of delivering this responsibility, OCAG has taken some initiatives like PFM lecture series, formation of study group, sharing of PFM related documents etc. These initiatives have been taken to make the knowledge, understanding and experience of the audit officials robust, comprehensive and homogeneous. Moreover, Appropriation Audit on grants and appropriation to be conducted following two steps, that is, Sanction Audit and Expenditure Audit. OCAG has already given directives to all Audit Departments to conduct Appropriation Audit by issuing various audit instructions. In this connection, a number of officials have been trained and also given guidelines to conduct Appropriation Audit. OCAG has issued instructions to prepare a suitable format for Appropriation Accounts and Finance Accounts in harmony with the new classification chart. To make public sector accounting management more effective through improved public service delivery, an emphasis has been put on strengthening the iBAS++ system. With a view to reducing the sufferings of the pensioners, Electronic Fund Transfer (EFT) activity has been geared up through the Chief Accounts Office (CAO), Pension & Fund Management. It is expected that it will be a milestone in providing service to the doorstep of the pensioners. "Centralized accounts keeping with decentralized service delivery reducing cost of audit activities" would be the vision in the days

to come. The Accounts and Report wing of the Office of the Comptroller and Auditor General of Bangladesh (OCAG) has been proactive in issuing various orders and instructions. These orders and instructions are mainly focused on the quality improvement of the audit procedure. OCAG is working on timeliness of accounts compilation in order to reduce audit cost and time. It is expected that, in future, Audit Department will play its due role in improving service delivery while establishing accountability in use of public fund through effective audit.

Newly appointed Comptroller and Auditor General takes oath



Mr. Mohammad Muslim Chowdhury took oath as the 12th Comptroller and Auditor General of Bangladesh on Tuesday, 17th July, 2018. Chief Justice Mr. Syed Mahmud Hossain administered the oath at the Judges Lounge of Supreme Court

As per Article: 127(1) of the Constitution of Bangladesh, the Honorable President of the People's Republic of Bangladesh appointed Mr. Mohammad Muslim Chowdhury as the Comptroller and Auditor General of Bangladesh. He took oath as the 12th Comptroller and Auditor General of Bangladesh on Tuesday, 17th July, 2018. Honorable Chief Justice Mr. Syed Mahmud Hossain administered the oath at the Judges Lounge of Supreme Court. Mohammad Muslim Chowdhury is a highly accomplished person with an illustrious career in the civil service spanning across 33 years. Having an in-depth and broad-based knowledge and experience on matters of Public Financial Management, Administration and Governance, he was a member of Bangladesh Civil Service (Audit and Accounts Cadre) 1984 batch. Prior to assuming the office of Comptroller and Auditor General of Bangladesh on 17th July, 2018, Mr. Chowdhury was the Secretary, Finance Division, Ministry of Finance. Before his elevation to the position of Secretary to the Government, Finance Division, Ministry of Finance, he had served as Deputy Secretary, Joint Secretary and Additional Secretary in the same ministry. He had held various positions under the Office of the Comptroller and Auditor General, Controller General of Accounts (CGA) and Controller General Defence Finance (CGDF).

Academically, he is a Master of Science (MSc) in Finance and Accounting with distinction from the University of Birmingham, UK. He graduated with a Bachelor degree in Commerce with Honours and Master of Commerce in Accounting from the University of Chittagong, Bangladesh.

During his long and illustrious career in the civil service, Mr. Chowdhury had pioneered the Public Sector Financial Management Reform and was awarded the "Jana Prashashan (Public Administration) Award, 2017" for his contribution to the improvement of Public Service delivery system. He was passionate about introducing e-Governance in Finance and engaged in a supervisory role at the Integrated Financial Management Information System (iBAS++) development and implementation process. He was actively involved in the initial formulation and implementation of Public Private Partnership (PPP) Framework in Bangladesh and drafted the PPP Strategy and Policy issued by the Government of Bangladesh. He had steered the formulation of New Budget and Accounting Classification System (BACS) in the Government planning, budgeting and accounting process from Fiscal Year 2018-19.

As a Consultant, Mr. Chowdhury worked in the PFM reform area with World Bank and Department for International Development (DFID) funded projects. In the past, he worked as Director on the Board of Directors of Bangladesh Krishi Bank, Sonali Bank Ltd. (also was acting Chairman), Bangladesh Biman, Titas Gas Transmission and Distribution Company Ltd., Eastern Refinery Ltd. and Dhaka BRT Company Ltd. He was also a Council Member of ICMAB and National Heart Foundation. He was the first Managing Director (MD) and Chief Executive Officer (CEO) of the Government-owned largest Infrastructure Financing Company, BIFFL. He worked as Director to the Board of Directors of SAARC Development Fund (SDF), Headquartered in Bhutan.

He is a widely travelled person and has visited countries like USA, UK, Canada, Belgium, Denmark, France, the Netherlands, Sweden, India, Pakistan, Malaysia, Indonesia, Sri Lanka, Cambodia, Nepal, Japan, Bhutan, Singapore, the Philippines, Saudi Arabia, UAE, China, Hong Kong, Myanmar, Kenya, Morocco, Peru, Germany, Austria, Fiji and Australia.

Mr. Chowdhury was born in a respected noble Muslim family of Chittagong. In his personal life, he is married. His wife Mrs. Sabina Haque is a teacher by profession. They are blessed with two daughters.

Honorable CAG Mr. Mohammad Muslim Chowdhury delivered a series of lectures on 'Evolution of Public Financial Management in Bangladesh'. He took a total of 08 classes from 08/08/2018 to 08/11/2018 in F K M A Baqui Auditorium of CAG office in presence of senior and mid-level officials of Audit and Accounts department.

Having an in depth and broad-based knowledge and experience on matters of Public Financial Management, Administration and Governance, he gave a conceptual framework of PFM in these classes. He also discussed about history and evolution of Audit and Accounts Department beginning from the colonial era. Besides, he expressed his concern about the management and automation of Public Accounts to make it more effective for public service delivery. He articulated his vision as 'centralized accounts keeping with decentralized service delivery reducing cost of audit activities'. His main purpose was to develop Audit Department as a knowledge-based department through its functions contributing in developing quality public service delivery and establishing good governance as a part of transparency and accountability. All the officials of Audit and Accounts Department got inspired and highly benefitted from these precious lectures.

Various Orders & Instructions issued by OCAG:

The Accounts and Report (A&R) wing of Office of the Comptroller and Auditor General of Bangladesh (OCAG) was very proactive in issuing various orders and instructions on behalf of CAG from July to December, 2018. These orders and instructions are mainly focused on quality development of public audit procedure (planning, field audit and report), Appropriation Audit (Sanction & Expenditure), management of GPF and Loans & Advance, management of Public Accounts for making it more effective for public service delivery, review of compiled accounts of Self Accounting Entities (SAEs) by concerned Audit Departments, guidelines for mission audit teams before and during audit, work distribution among 10 Directors General of Audit Departments according to relevant grant and appropriation for ministries/divisions and forming a committee for preparing a draft for a comprehensive act in the light and spirit of our Constitution, The Comptroller and Auditor General (Additional Functions) Act of 1974 and The Comptroller and Auditor General (Remuneration and Privileges) Act of 1998.

The Supreme Audit Institution of Bangladesh has been elected as a member of Governing Board of Asian Organization of Supreme Audit Institutions (ASOSAI) for three years ranging from 2018 to 2021. The election took place during the 14th assembly of Hanoi in Vietnam from 19th to 22nd September, 2018. The other elected members of the Governing Board are Indonesia, Nepal, Kuwait & Russia. A six-member delegation from SAI Bangladesh headed by the Comptroller and Auditor General (CAG) of Bangladesh Mr. Mohammad Muslim Chowdhury attended the conference. Mr. Md. Aftabuzzaman (DG, Commercial Audit), Ms. Farmeen Mowla (Director, FIMA), Mr. Md. Naoshad Hossain (ADCAG, Admin), Mr. Md. Firoz Khan (ACAG, Report) were present among others. A signing ceremony for Cooperation Agreement between SAI Bangladesh and State Audit Bureau of Kuwait was also held in Hanoi.
