#### **CAG'S NOTE**

In continuation of its endeavor, OCAG Bangladesh has shown its utmost sincerity to overcome the challenges of implementation of Strategic Plan (SP) 2013-2018 during the last six months of the year 2017-2018. A series of activities was taken to make the changes possible and visible. A seminar with the theme "Strategic Plan: Myths versus Reality" was organized in July to start the change process with a view to bring all concern on the same page. Implementation Matrix 2017-2018 was finalized and disseminated among the audit directorates where specific targets and KPIs were set for all the audit directorates along with OCAG itself. A high powered strategy execution cell (SEC) was formed to monitor the progress and implementation of the Implementation Matrix 2017-2018. This is for the first time that operational plan to implement the SP is formulated by each of the Audit Directorates, which acts as an annual performance agreement between OCAG and Audit Directorates. All the Audit Directorates are committed to act as per the approved operational plan. As many as 700 entities were identified consisting of nearly 22,500 auditable units for the year 2017-2018 and OCAG is supposed to get about 70 Audit Reports including performance, issue based, environmental, IT audit reports by the end of 2017-2018. To make this huge and daunting task possible OCAG has carried out several initiatives like issuance of audit instruction mentioning specific uniform audit cycle for all Audit Directorates. Again as a believer of quality audit, OCAG has taken the motto "No training, No audit" and "No Planning, No audit". To fulfill these mottos a remarkable initiative has been taken to provide 'off site' training to the entire Audit Directorates simultaneously with the support and guidance of FIMA and near about 600 audit staffs have been trained through this process. To materialize the implementation matrix the monitoring of OCAG has been increased which entails many activities like one to one meeting between OCAG and Audit Directorates, defining quantifiable KPIs, and introduction of performance scorecard to measure the performance of different Audit Directorates in line with the approved

operational plan. Another remarkable achievement of OCAG in this 6 months was that the reformation of Audit Quality Assurance Cell (AQAC). A policy and checklist has been drafted to conduct the quality assurance activities, which would be finalized after piloting this checklist along with the checklist provided by IDI in real field. OCAG is continuously striving for the enhancement of the quality of its audit work and for that purpose; a satisfaction survey would be conducted among the auditee to improve the quality of audit.

Public accounts committee of the national parliament was as vibrant as before and OCAG submitted another 66 Audit Reports and 13 Appropriation & Finance Accounts, which was tabled in the full session of the parliament on 12 September 2017. With the addition of these reports, which are mostly of contemporary time, the PAC will continue its role with the cooperation of OCAG in establishing transparency and accountability in public financial management for achieving the ultimate goal of Good Governance.

As per the demand of the time OCAG is also doing its best to cope up with the national and international scenario. A performance audit is being conducted to see the preparedness of the government in achieving Sustainable Development Goals (SDGs) with the technical cooperation of IDI of INTOSAI. OCAG is always highlighting the importance of SDG and the role of SAI in it's achievement throughout the department as well as among the stakeholders. The issue of SDG is planned to be incorporated in all the training activities of the FIMA. Beside these, environmental audit and IT audit are being conducted to foster and monitor the Govt. vision of 'Digital Bangladesh' and huge monetary involvement in climate resilience fund.

OCAG is now almost completed it's taxing in the right runway with the full transformation and implementation of ISSAI compliant risk based entity wide audit approach. Soon it will take off with the help and assistance of all stakeholders and fly high in the sky with an ultimate view of serving people and make a prosperous nation.

# CAG attends INTOSAI-Donor Cooperation and Capacity Building Committee Meeting held at Washington D.C., United States of America

The INTOSAI-Donor Cooperation is an ambitious initiative. The INTOSAI is working to strengthen and scale up support for SAIs, ensure that all SAIs develop their own strategies as the basis for their development and working to influence the behavior of all actors in the SAI and donor world to work in a coordinated fashion that respects the recipient's ownership of its own development.

The Honorable Comptroller and Auditor General Mr. Masud Ahmed along with Mr. Abul Kalam Azad, DG, Mission Audit Directorate attended the INTOSAl-Donor Cooperation and Capacity Building Committee Meeting which was hosted by the World Bank and took place in Washington D.C., United States of America from 18-21 September 2017.

The Cooperation's main focus in the current program period is on the new round of the global call for proposals. For the next year or so the main concentration will be on the tier 2, which is a specialized initiative to scale up support for the most challenged SAIs. SAIs in the most challenged environments face fundamental legal obstacles that hamper their ability to fulfil their role in society, but also more basic constraints such as limited human and financial resources and an ability to act autonomously. Financing a SAI can be challenging in a country that lacks financial resources, but failing

to recognize the importance of independence and organizational autonomy is a symptom of a systemic institutional weakness, where the checks and balances that ensure that those in power are accountable for their actions are not being recognized. In many countries we see that SAIs are being challenged by their environments. The hope for tier 2 support is that INTOSAI can help the SAIs to such an extent that they are no longer challenged by their environment.

# CAG attends ASOSAI Seminar on Improvement and Innovation of Audit Process - including Audit on Preparedness for Implementation of Sustainable Development Goals (SDGs), held at Kuwait City, Kuwait

The purpose of the seminar was to discuss and identify best practices and recommendations of Improvement

and Innovation of Audit Process. The seminar addressed the following sub themes:

- a. Improvement and Innovation of Audit Planning
- b. Improvement and Innovation in conducting Audit
- c. Improvement and Innovation in Reporting; and
- d. Improvement and Innovation of Follow-up

The seminar also aimed at sharing experience of audit on preparedness for implementation of SDGs and discussing issues and challenges, where a guest speaker from European Court of Auditors and some selected participating SAIs made presentations to share ideas and experiences. At the end of the seminar, the participants jointly formulated best practice and recommendation of Improvement and Innovation of Audit Process.

The discussion also connotes and connects the operations and intersections of the two traditional forms of accountability exerted by both the public audits (Supreme Audit Institutions) and Parliament through the Committee system. Participants also discuss and try to understand the common obstacles the executive faces when it comes to prudent spending. Discussions also established how crucial establishing relationship with stakeholders is, for the necessity of obtaining accurate data and information.
